**CLAIM**

The ornamental design for the bicycle frame, as shown and described.

**DESCRIPTION**


FIG. 1 is a front perspective view of the bicycle frame taken from a right side with a kickstand in an up position;

FIG. 2 is a rear perspective view of the bicycle frame taken from a left side with the kickstand in a down position and including simplified pedals;

FIG. 3 is a right side elevational view of the bicycle with the kickstand in the up position and including simplified pedals; and,

FIG. 4 is a left side elevational view of the bicycle with the kickstand in the up position and including simplified pedals. The broken lines showing other portions of a bicycle including the kickstand, pedals, and other portions form no part of the claimed design.







